1. Describe how you will deliver continuous learning opportunities for all students, including special student populations.

Eman Schools is hosting online Zoom Classrooms (Monday-Thursday) from 8:30 a.m.-3:30 p.m. & on Fridays Zoom sessions are for 1:1 conference with students and support help from other support staff. Students with IEP have been assigned 1-2 support staff for 1:1 Zoom sessions to help with homework, organization and any other needs the student has.

2. Describe how your district communicates expectations for continuous learning implementation to 1.) students, 2.) families, and 3.) staff.

Our expectations are communicated to students, families and teachers through emails using our online Gradelink system, as well as our website emanschool.org.

School-wide emails are sent of our expectations for classroom participation and homeroom and subject teachers also send their own communication emails with assignments, due dates, rubric and Zoom code and/or link.

Daily homework and in class assignments are posted daily on Google Classrooms for students in 6th-12th grades and through Gradelink and Zoom platforms for those students in PreK-5th Grades.

3. Describe student access to academic instruction, resources, and supports during continuous learning.

Zoom Platforms run continuously from 8:30-3:30 p.m. with all subject material covered just like it is during the normal school day including Art, PE, Foreign Language and even Math recitation.

Tutoring and homework help is being covered by 3 support staff members on a daily basis.

4. What equipment and tools are available to staff and students to enable your continuous learning plan? Please list.

PreK-5th Grades: Printed Daily packets, all workbooks, textbooks & Zoom accounts/codes for all classes.

6th-12th Grades: All textbooks, Google Classrooms & Zoom accounts/codes for all classes.

ALL students have their own technology at home to be able to connect remotely.

5. Describe how educators and support staff are expected to connect with students and families on an ongoing basis.

Teachers and support staff are connected with students and families through live Zoom sessions, Google Classrooms and using Gradelink to post grades and send emails.

6. Describe your method for providing timely and meaningful academic feedback to students.

Students are given a grade for their in-class assignments & homework within 24-48 hours and it is posted on Gradelink & Google Classroom with meaningful comments and feedback. Students are also assessed online using multiple platforms including IXL, USA Test Prep and individual teachers own assessments.

Section Two: Achievement and Attendance

7. Does your continuous learning plan provide an avenue for students to earn high school credits? If so, describe the approach.

Students in 9th-12th Grades (& those taking Algebra 1 or HS courses in 7th+) will be continuing in their same registered course from March 16th-May 22nd (Last day of 2019-2020 school year). Students are provided with daily Zoom lessons along with homework and assignments via Google Classroom. Assignments and assessments are graded and input into the Gradelink system for the semester grade.

8. Describe your attendance policy for continuous learning.

Attendance is taken daily in all classes the students attends via the Zoom Platform. Parents of students that are absent are sent an email via Gradelink to the parent inquiring about the absence from their daily class along with the recorded Zoom lesson link and what in class assignment and/or homework that was missed.

9. Describe your long-term goals to address skill gaps for the remainder of the school year.

Eman Schools is providing 1:1 tutoring and homework help assistance for ANY student requesting assistance, as well as those students that have been suggested to our help desk. We are still offering IEP assistance and weekly meetings with our social worker, via Zoom as well.

10. Describe your professional development plan for continuous learning.

Teachers are provided PD opportunities once weekly on Fridays during a Zoom conference. This PD includes opportunities to improve in their Zoom classrooms (based on admin walk-throughs on Zoom), feedback from other teachers on the Zoom platform and or suggestions and tips that have worked for others.
